Certification and Acceptance of Responsibility

I fully understand these documents and will abide by them and their application to the use of any type of watercraft on Lake Holiday and the use of wake enhancement devices are prohibited, and agree to accept any penalties for infraction thereof, by myself, or any other person operating a boat. I have taken and successfully passed a written boating test distributed by the Association Office.

I certify that the boat I am registering, regardless of whether it's equipped with a motor, is equipped with the safety equipment and running gear as specified in the VA Boating Handbook, that the bilge/engine compartment is equipped with a functional oil absorbing device, and that there are no functional built-in flushable or self-contained toilet facilities or sleeping facilities on board.

Hold Harmless & Indemnification Agreement

I further certify that I am aware that any use of Lake Holiday whatsoever is at my own risk, and that this boat is insured by a liability policy and will remain insured while registered for use on Lake Holiday. The boat owner assigns and other successors in interest will indemnify and hold LHCC, its agents and employees harmless for any and all damages, accidents, casualties, occurrences, or claims which might arise or be asserted against Lake Holiday from the use of LHCC common areas for the storage and/or parking of your boat.

I understand that as the owner I will be held responsible for informing each operator of the registered boat about all Lake Holiday boating rules and that I am responsible for monitoring such operators for adherence to these rules.

Violations of the rules by any operator will be treated as though the Owner was the operator.
